DECLARING MUNICIPAL ORDINANCE NO. 2021-04 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE INTEGRATING THE COLLECTION OF BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS IN THE MUNICIPALITY OF BALUNGAO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Municipal Ordinance No. 2021-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 447 (3) (i) of R.A. No. 7160; Section 11 (f) of R.A. No. 11032 otherwise known as "An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services";

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c), and 511(a) of RA 7160 are complied with;
