DECLARING ORDINANCE NO. 26-2020 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “AN ORDINANCE RECTIFYING POSITION TITLE OF MEDICAL OFFICER V, SALARY GRADE 22 TO MUNICIPAL GOVERNMENT ASSISTANT HEAD I (MEDICAL SPECIALIST 1), SALARY GRADE 22 AND ABOLISHING CREATED PLANTILLA POSITION OF MEDICAL OFFICER IV, SALARY GRADE 20 UNDER THE PRIMARY CARE FACILITY-MUNICIPAL HEALTH OFFICE (PCF-MHO) OF ORDINANCE NO. 21-2020” AS WITHIN THE CONFERRED POWER OF THE SANGGUNIANG BAYAN TO ENACT




