DECLARING MUNICIPAL ORDINANCE NO. 03, S-2017 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "AN ORDINANCE UPDATING THE ZONING REGULATIONS FOR THE MUNICIPALITY OF SANTO TOMAS, PANGASINAN ENTITLED "THE INTEGRATED ZONING ORDINANCE OF THE MUNICIPALITY OF SANTO TOMAS, PANGASINAN" AND PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT AND AMENDMENT THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Municipal Ordinance No. 03, Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, and Provincial Land Use Committee (PLUC), have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (2) (ix) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Zoning Ordinance of Sto. Tomas, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to the guidelines of Memorandum Circular No. 2000-130 of the Department of the Interior and Local Government as embodied in Section 2 of Executive Order No. 72, S-1993;

WHEREAS, the PLUC found the Zoning Ordinance of Sto. Tomas, Pangasinan to be in conformity with the existing Land Use Planning Guidelines, Laws and Regulations and other development plans of the Province;

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan shall comply with the publication requirement per Section 59 of RA 7160 before the subject Zoning Ordinance is effected;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject municipal ordinance in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Clemente B. Arboleda, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jeanne Jinky C. Zaplan, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 03, S-2017 of the Sangguniang Bayan of **Sto. Tomas**, Pangasinan, entitled “An Ordinance updating the Zoning Regulations for the Municipality of Santo Tomas, Pangasinan entitled “The Integrated Zoning Ordinance of the Municipality of Santo Tomas, Pangasinan” and providing for the administration, enforcement and amendment thereof” as within the conferred powers of the Sangguniang Bayan to enact;
