APPROVING RESOLUTION NO. 96, S-2021 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE THIRD SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its SB Resolution No. 96, Series of 2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Infanta, Pangasinan had identified items in their Third Supplemental Investment Program for CY 2021. This was endorsed to the Sangguniang Bayan for approval on December 10, 2021 through MDC Resolution No. 4, Series of 2021;

WHEREAS, the Second Supplemental Investment Program of the municipality covers the granting of Other Personnel Benefits to the municipal officials and employees, fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and for the implementation of disaster risk reduction and management program of the LGU;
