APPROVING RESOLUTION NO. 35, S-2020 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 FOR FY 2020 OF THE MUNICIPALITY OF BUGALLON, PANGASINAN AMOUNTING TO FOUR MILLION FIVE HUNDRED THREE THOUSAND EIGHTY SIX PESOS AND SIXTY FOUR CENTAVOS (P4,503,086.64)"

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 35, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Bugallon, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on July 29, 2020 by the MDC thru Resolution No. 03, S-2020 and was favorably acted upon by the Sangguniang Bayan on August 10, 2020 thru SB Resolution No. 35, S-2020;

WHEREAS, the Supplemental Investment Program No. 3 of the municipality covers fund augmentation for the Personal Services (Hazard Pay), and Maintenance and Other Operating Expenses and implementation of various infrastructure projects of the municipality;
