**APPROVING RESOLUTION NO. 316, S-2020 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3, CY 2020 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Resolution No. 316, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Lingayen, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on December 1, 2020 by the Municipal Development Council through Resolution No. 06, S-2020;

**WHEREAS**, the Supplemental Investment Program No. 3 of the municipality covers the fund augmentation for Personal Services (Collective Negotiation Agreement Incentive) for municipal employees and officials, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of development projects of the Municipality of Lingayen;

**WHEREAS**, funding support for the implementation of this Supplemental Investment Program, in the amount of P11,956,691.00. is embodied in their proposed Supplemental Budget No. 3, CY 2020, which was enacted by their Sangguniang Bayan on December 14, 2020 through Appropriation Ordinance No. 4, S-2020;


