**APPROVING RESOLUTION NO. 247, S-2020 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "APPROVING THE MDC RESOLUTION NO. 6, SERIES OF 2020 FOR THE REALIGNMENT OF APPROVED PROJECTS OF 20% DEVELOPMENT FUND OF CY 2020 – CONSTRUCTION OF SENIOR CITIZEN'S BUILDING IN BARANGAY ARTACHO AMOUNTING TO ONE MILLION PESOS (P1,000,000.00) AND CONSTRUCTION OF DAY CARE CENTER IN BARANGAY CABUAAN AMOUNTING TO ONE MILLION PESOS (P1,000,000.00) WITH A TOTAL AMOUNT OF TWO MILLION PESOS (P2,000,000.00) FOR THE ALLOCATION OF FUNDS FOR FOOD ASSISTANCE AND OTHER RELIEF GOODS FOR COVID-19 AFFECTED HOUSEHOLDS"**

**WHEREAS**, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 247, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that on July 6, 2020, the Local Development Council of Bautista, Pangasinan has endorsed the realignment of two (2) previously approved development projects namely: construction of senior citizen's building at Brgy. Artacho, and construction of day care center in Brgy. Cabuaan to Food Assistance and Other Relief Goods for COVID-19 affected households amounting to P2,000,000.00 thru MDC Resolution No. 06, S-2020 to the Sangguniang Bayan for approval. This is embodied in the Supplemental Investment Program No. 4 CY 2020 of the municipality;


