PROVINCIAL RESOLUTION NO. 901-2021

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE FOR THE PROVISION OF SEED FUNDS FOR THE ESTABLISHMENT OF FOOD PROCESSING FACILITY AND PROCUREMENT OF DELIVERY TRUCK UNDER THE ENHANCED “KADIWA NI ANI AT KITA FINANCIAL GRANT ASSISTANCE PROGRAM”

WHEREAS, the Provincial Government of Pangasinan has been determinedly pursuing programs and projects to hasten the development of the agriculture sector of the province to help farmers, cooperatives, associations and micro entrepreneurs become self-sufficient and viable partners for economic growth;

WHEREAS, in support to agricultural development in the province, food processing facilities are being set up in strategic locations as training and production hubs for cooperatives and community organizations engaged in fish, vegetable and meat processing;

WHEREAS, the Department of Agriculture has established the Enhanced “KADIWA ni Ani at Kita Financial Grant Assistance Program” to provide financial grant assistance to local government units to further enhance their capacities in value-adding activities in the food supply chain including processing, packaging, warehousing and transport;

WHEREAS, the Provincial Government of Pangasinan, through Provincial Governor Amado I. Espino III, has expressed interest in availing of financial grant from the Department of Agriculture in support to its food processing facilities including their logistical requirements;

WHEREFORE, in view of the foregoing, on motion of SP Member Liberato Z. Villegas, duly seconded, it was –


