**APPROVING RESOLUTION NO. 248, S-2020 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 UNDER MDC RESOLUTION NO. 7, CY 2020 AMOUNTING TO TWO MILLION SIX HUNDRED TWENTY NINE THOUSAND FIVE HUNDRED TWENTY SEVEN PESOS AND 22/100 (P2,629,527.22)”**

**WHEREAS**, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 248, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that on July 6, 2020, the Local Development Council thru MDC Resolution No. 7, S-2020 has endorsed the Supplemental Investment Program No. 5 of the municipality to the Sangguniang Bayan for approval;

**WHEREAS**, the Sanggunian approved the Supplemental Investment Program No. 5 thru Resolution No. 248, S-2020 dated August 3, 2020;

**WHEREAS**, the Supplemental Investment Program No. 5 with an investment requirement amounting to P2,629,527.22 covers the purchase of rescue vehicle (LGU Counterpart), fund augmentation for personal services, and maintenance and other operating expenses of Office of the Mayor;
