**RESOLUTION NO. 906-2020**

**DECLARING ORDINANCE NO. 04-2020 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "AN ORDINANCE ON MANDATORY PRACTICE OF PHYSICAL DISTANCING BY ALL PERSONS WHO ARE IN THE JURISDICTION OF THE MUNICIPALITY OF ROSALES, PANGASINAN FOR THE MANAGEMENT AND CONTROL OF THE CORONAVIRUS DISEASE (COVID-19)" AS WITHIN THE CONFERRED POWER OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 04, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii), (5) (xii) of RA 7160; Provincial Ordinance No. 240-2020 and Section 1 (E) of Executive Order No. 0033-2020 of the Provincial Governor;

**WHEREAS**, however, the Sanggunian shall consider the points raised by the Provincial Legal Officer in her written opinion dated September 8, 2020;

**WHEREAS**, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;


