RESOLUTION NO. 908-2021

DECLARING ORDINANCE NO. 2019-09 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING WELFARE SERVICES, SPECIAL PRIVILEGES AND BENEFITS TO SOLO PARENTS AND THEIR CHILDREN, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2019-09 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 458 (a) (1) (viii) of R.A. No. 7160, Republic Act No. 8972 otherwise known as “An Act Providing for Benefits and Privileges to Solo Parents and their Children, Appropriating Funds Therefor and for Other Purposes” and Memorandum Circular No. 08, S-2004 issued by the Civil Service Commission, with the subject titled: Guidelines on the Grant of Parental Leave to Solo Parents;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511(a) of RA 7160 are complied with;


