APPROVING RESOLUTION NO. 70-2021 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED, "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02 FOR THE CALENDAR YEAR 2021 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its SB Resolution No. 70-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in consonance to Sections 106, 109 and 114 of R. A. No. 7160;

WHEREAS, the Local Development Council of Burgos, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021. This was indorsed to the Sangguniang Bayan for approval on May 31, 2021 by the Municipal Development Council through MDC Resolution No. 2021-002;

WHEREAS, the Supplemental Investment Program No. 2 covers fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of COVID-19 related programs and development projects;

WHEREAS, a total investment requirement amounting to P9,830,221.53 is needed for the implementation of the Supplemental Investment Program. This will be sourced from reversion of funds (P1,000,000.00), savings from 20% Development Fund of previous years (P7,622,684.33) and unexpended balance of 5% MDRR Fund (P1,207,537.20);

WHEREAS, however, for the programs/projects/activities to be funded by the unexpended balance of 5% MDRRM Fund (P1,207,537.20), there is a need to prepare a revised AIP in accordance with Item 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;




