DECLARING ORDINANCE NO. 05, S-2021 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, **ENTITLED** ORDINANCE CREATING THE PLANTILLA POSITIONS OF ADMINISTRATIVE ASSISTANT III (ELECTRICIAN FOREMAN), **ADMINISTRATIVE ASSISTANT** II (LABOR FOREMAN), ADMINISTRATIVE ASSISTANT II (CLERK IV) AND ADMINISTRATIVE AIDE III (UTILITY WORKER II) UNDER THE OFFICE OF THE INFANTA WATERWORKS SYSTEM OF THE LOCAL GOVERNMENT OF INFANTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO **ENACT**
