**RESOLUTION NO. 914-2020**

**DECLARING MUNICIPAL ORDINANCE NO. 07-09072020 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "AN ORDINANCE IMPOSING CURFEW IN THE MUNICIPALITY OF POZORRUBIO FROM EIGHT O'CLOCK IN THE EVENING (8:00 P.M.) TO FIVE O'CLOCK IN THE MORNING (5:00 A.M.) FOR THE DURATION OF THE COMMUNITY QUARANTINE, PROVIDING EXEMPTIONS AND PENALTIES THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 07-09072020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to the General Welfare Clause under Sections 16, 17 (b) (2) (iii) and (iv) and 447 (5) (xii) of RA 7160; and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines issued by the IATF with Amendments as of June 03, 2020, Section 8, paragraph 1;

**WHEREAS**, however, the Sanggunian shall consider the points raised by the Provincial Legal Officer in her written opinion dated September 21, 2020;
