PROVINCIAL ORDINANCE NO. 92-2000

AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 80-99 PARTICULARLY SECTION 1 (m)

Section 1. Section 1 (m) of Provincial Ordinance No. 80-99 is hereby amended by dividing the Committee on Labor, Trade and Cooperatives into two (2) separate and distinct committees to be known as the Committee on Labor and the Committee on Trade and Cooperatives;

Section 2. The two (2) separate and distinct committees shall be formed with their respective duties, powers and general jurisdiction specified hereunder:

COMMITTEE ON LABOR

All matters relating to labor employment and human resource development, maintenance and promotion of employer-employee cooperation, complaints, and grievances; labor education, standard and statistics; organization of the labor market, including recruitment, training and placement of workers and export of human resource, promotion and development of employment intensive technology; civil service and the status of officers and employees of the provincial government including their retirement, pension, gratuity, provincial government organization and management; personnel administration, position classification and pay plan, staffing patterns; creation of positions; policy formation of the economical, efficient and effective local government administration, conduct and ethical standards for local officials and employees.
