PROVINCIAL RESOLUTION NO. 928-2021

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE UNIVERSITY OF SANTO TOMAS THROUGH THE CENTER FOR CONSERVATION OF CULTURAL PROPERTY AND ENVIRONMENT IN THE TROPICS (CCCPET) FOR THE CONCEPTUALIZATION AND ESTABLISHMENT OF THE PANGASINAN PROVINCIAL MUSEUM DEVELOPMENT PROJECT

WHEREAS, Pangasinan is among the great provinces in the Philippines which is historically, geographically and politically rich in cultural heritage and resources as well as artistic creations, and yet the Province does not have its own official provincial museum that will showcase, preserve and promote the rich cultural, literary and historical legacy of Pangasinenses;

WHEREAS, one of the mandates of RA 10066, otherwise known as the National Cultural Heritage Act of 2009, provides that local government units shall maintain an inventory of cultural property under its jurisdiction;

WHEREAS, for such reasons, the Provincial Government of Pangasinan intends to establish the Pangasinan Provincial Museum which will serve as the premier heritage interpretation center of the Province for educational and engaging experience of museum audiences;

WHEREAS, the University of Santo Tomas, through the Center for Conservation of Cultural Property and Environment in the Tropics (CCCPET), has the technical knowledge and expertise in museum development as well as cultural conservation and preservation;

WHEREAS, the conceptualization and establishment of the Pangasinan Provincial Museum Development Project is a collaborative vehicle between the Provincial Government of Pangasinan and the University of Santo Tomas to ensure proper interpretation and transmission to the next generation of Pangasinenses;

WHEREAS, the realization of the said Project will preserve and enrich such distinct culture and history of the great Province of Pangasinan;

WHEREAS, in the above purpose, the Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Honorable Governor Amado I. Espino III and the University of Santo Tomas, represented by its Rector, Rev. Fr. Richard G. Ang, O.P.;

WHEREFORE, in view of the foregoing, on motion of SP Member Margielou Orange D. Humilde-Verzosa and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Honorable Governor, Amado I. Espino III, to enter into and sign a Memorandum of Agreement with the University of Santo Tomas through the Center for Conservation of Cultural Property and Environment in the Tropics (CCCPET) for the conceptualization and establishment of the Pangasinan Provincial Museum Development Project;

RESOLVED, FINALLY, that copies of this resolution be furnished to Honorable Governor, Amado I. Espino III, Province of Pangasinan, and Rev. Fr. Richard G. Ang, O.P., Rector, University of Santo Tomas, for their information and guidance.
