PROVINCIAL RESOLUTION NO. 929-2021

APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 8 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2021

WHEREAS, presented for consideration is the Supplemental Investment Program No. 8 of the Province of Pangasinan as endorsed by the Provincial Development Council through PDC Execom Resolution No. 19-21;

WHEREAS, Supplemental Investment Program No. 8 contains other priority programs, projects and activities that are not included in the approved 2021 Annual/Supplemental Investment Programs of the Province of Pangasinan;

WHEREAS, the Supplemental Investment Program contains fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of various provincial offices and hospitals, for the operation of Dairy Farm in Laoac, Pangasinan, COVID-19 Logistics, Economic Recovery Program, and implementation of development projects of the Province;

WHEREAS, the investment requirement for the full implementation of the said Supplemental Investment Program is embodied in the proposed Supplemental Budget No. 4 of the Province of Pangasinan (P225,795,537.95) and Special Education Fund Supplemental Budget No. 1 CY 2021 (P17,000,000.00);

WHEREAS, the said Supplemental Investment Program also includes additional infrastructure projects for inclusion in the CY 2021 Annual Investment Program to be funded from the CY 2021 20% Development Fund;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;
