## **PROVINCIAL RESOLUTION NO. 93-2019**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO TERMS OF PARTNERSHIP WITH THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT-I FOR THE IMPLEMENTATION OF THE LOCAL INVESTMENT PLAN FOR HEALTH THROUGH THE 2019 ANNUAL OPERATIONAL PLAN OF THE PROVINCE OF PANGASINAN**

**WHEREAS**, the Fourmula One Plus for Health, the flagship program of the Department of Health with its tagline “Boosting Universal Health Care, is the new strategic framework for health sector reforms in the country;

**WHEREAS**, the implementation of Fourmula One Plus for Health is directed towards achieving the following health system end goals identified in the Philippine Development Plan, Sustainable Development Goals, and the Ambisyon Natin 2040, specifically for better health outcomes, more equitable health care financing, and more responsive health system;

**WHEREAS**, the Local Investment Plan for Health (LIPH) shall serve as a key instrument to forge the partnership between the Department of Health and the Province of Pangasinan to carry out the objectives of the Fourmula One Plus for Health in the implementation and consolidation of support for health reforms in the Province;

**WHEREAS**, through the LIPH, the Province of Pangasinan shall receive financial allocation support from DOH and other sectors for the implementation of its approved Annual Operational Plan for 2019;

**WHEREAS,** the LIPH guarantees the implementation of programs/projects/activities in the Province of Pangasinan, together with its component LGUs, toward achieving a more responsive health system and equitable health care financing;

**WHEREAS,** the Provincial Government of Pangasinan, in partnership with the DOH, shall support the “Fourmula One Plus for Health” program geared towards ensuring the delivery of health services for every Pangasinense through the implementation of the LIPH;

**WHEREAS,** for the above purpose, the Terms of Partnership shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino, III and the Department of Health, represented by Dr. Valeriano Jesus V. Lopez, Regional Director;
