APPROVING RESOLUTION NO. 2021-161 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (RAIP), CY 2021 OF SUAL, PANGASINAN AMOUNTING TO NINE HUNDRED SIXTEEN MILLION SEVENTY ONE THOUSAND SIX HUNDRED ONE & 55/100 PESOS (P916,071,601.55)"

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its SB Resolution No. 2021-161 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991:

**WHEREAS,** the Local Development Council of Sual, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program CY 2021 on November 2, 2021 through Resolution No. 04, Series of 2021;

**WHEREAS**, the 2021 AIP of the Municipality of Sual was revised to integrate a Disaster Risk Reduction and Management project;

WHEREAS, the disaster risk reduction project was identified and prioritized by the LDRRM Council and endorsed trough MDRRMC Resolution No. 2, Series of 2021 and proposed to be funded by the municipality's unexpended balance of their LDRRMF CY's 2019 and 2020 Trust Fund in the amount of P8,071,601.55. This is in accordance with Item 6.5 of NDRRMC-DBM-DILG-Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of Interior and Local Government;
