PROVINCIAL RESOLUTION NO. 931-2020

AMENDING BY INSERTION THE SOURCE OF FUND IN PROVINCIAL RESOLUTION NO. 808-2020 ENTITLED "AUTHORIZING THE GRANT OF P5,000.00 FINANCIAL ASSISTANCE TO ALL JOB ORDER EMPLOYEES/CONTRACT OF SERVICE EMPLOYEES/CONSULTANTS IN THE PROVINCIAL GOVERNMENT OF PANGASINAN" TO BE CHARGED TO PUBLIC AFFAIRS FUND – OTHER MAINTENANCE AND OTHER OPERATING EXPENSES APPROPRIATED IN SUPPLEMENTAL BUDGET NO. 5, CY 2020

WHEREAS, Section 468 (a) (1) (viii) of RA 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries, wages, allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, the Province of Pangasinan has already approved the grant of CY 2019 Performance Based Bonus to all qualified officers and employees of the Provincial Government pursuant to DILG-DBM Joint Memorandum Circular No. 2019-01 dated November 21, 2019 except for consultants/job orders/contract of service employees;

WHEREAS, the Provincial Government and its Officials find it meritorious to reward also, as a token of their dedicated service, all job order employees/contract of service employees/consultants for their unprecedented efforts and assistance in making Pangasinan always No. 1 in terms of public and civil service;

WHEREAS, likewise, the provincial government has appropriated for them funds in the form of financial assistance under Supplemental Budget No. 5, CY 2020 to help them shoulder their expenses during these lean months and period of public health crisis;




