RESOLUTION NO. 935-2020

DECLARING ORDINANCE NO. 2020-19 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING CONCESSIONS TO THE RENTALS OF COMMERCIAL STALLS OWNED BY THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN, TO WIT: A) STALLS AT PEOPLE'S FOOD COURT AND PLAZA ENRIQUE BRAGANZA: 1) FIFTY PERCENT DISCOUNT (50%) FOR THE MONTH OF MARCH, 2020; AND, 2) WAIVED FOR THE MONTHS OF APRIL AND MAY, 2020; B) FOR LUCAP FOOD COURT, ACCCO STALL AND MERMAID'S CAFÉ: 1) FIFTY PERCENT DISCOUNT (50%) FOR THE MONTH OF MARCH, 2020; AND, 2) WAIVED FOR THE MONTHS OF APRIL, MAY AND JUNE, 2020; AND C) FOR NEW SOUVENIR STALLS AT BRGY. LUCAP: 1) WAIVED FOR THE MONTH OF JULY, 2020" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2020-19 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to the General Welfare Clause of Section 16 and Section 192 of RA 7160; and Section 4 (z) of RA 11469 otherwise known as the "Bayanihan to Heal as One Act";



Lucap: 1) Waived for the month of July, 2020” as within the conferred powers of the Sangguniang Panlungsod to enact;
