PROVINCIAL RESOLUTION NO. 935-2021

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE CITY OF SAN CARLOS, PANGASINAN FOR THE USE OF FIFTEEN THOUSAND SEVEN HUNDRED FORTY-EIGHT (15,748) SQUARE METERS, MORE OR LESS, SITUATED IN ROXAS BOULEVARD, POBLACION, SAN CARLOS CITY AS A TEMPORARY PARKING AREA/TERMINAL FOR PUBLIC UTILITIES OF THE SAID CITY

WHEREAS, the Province is the registered owner of a parcel of land under Tax Declaration Nos. 0001-10290, 0001-10300, 0001-10301 and 0001-10303 containing an area of, more or less, Fifteen Thousand Seven Hundred Forty-Eight (15,748) square meters, situated in Roxas Boulevard, Poblacion, San Carlos City, Pangasinan;

WHEREAS, the City of San Carlos, Pangasinan has requested the Province of Pangasinan for the use of the said parcel of land as a temporary parking area/terminal for public utilities of the said city;

WHEREAS, the Province of Pangasinan, recognizing the role of the City of San Carlos in promoting peace and order, ensuring public safety and strengthening local government capability aimed towards effective delivery of basic services to the citizenry, hereby agrees to enter into a Memorandum of Agreement for the said use of parcel of land;

WHEREAS, the term of the Memorandum of Agreement shall be for a period of one year, subject to early termination for just and valid cause, or renewal upon the discretion of Pangasinan;

WHEREAS, there is a need for the Sangguniang Panlalawigan to authorize the Honorable Governor, Amado I. Espino, III, to enter into a Memorandum of Agreement with the City of San Carlos, Pangasinan, represented by Mayor Julier C. Resuello, for the use of the property;



NOW, THEREFORE, on motion of SP Members Angel M. Baniqued, Jr. and Vici M. Ventanilla, duly seconded, it was –


