### **RESOLUTION NO. 942-2020**

APPROVING RESOLUTION NO. 2020-141 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) CY 2020 OF SUAL, PANGASINAN AMOUNTING TO TWO MILLION SIX HUNDRED FORTY-SIX THOUSAND SEVEN HUNDRED NINETY-FIVE PESOS (P2,646,795.00)"

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2020-141 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program No. 7 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on August 19, 2020 through MDC Executive Committee Resolution No. 1, S-2020 and was favorably acted upon by the Sangguniang Bayan on September 7, 2020 through SB Resolution No. 2020-141;

**WHEREAS**, the said Supplemental Investment Program of the municipality covers fund augmentation for the Personal Services and Maintenance and Other Operating Expenses of some municipal offices;

WHEREAS, the said Supplemental Investment Program has an investment requirement of P2,646,795.00. Funding support for the implementation of the same is embodied in the proposed Supplemental Budget No. 7, CY 2020, which was enacted by the Sangguniang Bayan on September 7, 2020 through Appropriation Ordinance No. 08;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
