APPROVING MUNICIPAL RESOLUTION NO. 138-2021 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) SERIES OF 2021 OF ANDA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its SB Resolution No. 138-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. No. 7160;

WHEREAS, the Local Development Council of Anda, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program CY 2021 on September 14, 2021 through MDC Resolution No. 02, S-2021;

WHEREAS, the 2021 AIP of the Municipality of Anda was revised to integrate the Revised Local Risk Reduction and Management Fund Investment Plan (LDRRMFIP) prepared and endorsed by the LDRRM Council through MDRRMC Resolution No. 07, Series of 2021 on September 8, 2021. The LDRRMFIP includes various programs/projects necessary to effectively contain the spread of COVID 19 in the municipality, which are proposed to be funded from the municipality’s unexpended balances of their LDRRMF CY’s 2016, 2017, 2018, 2019 and 2020 (Trust Fund) in the amount of P6,671,884.16;




