APPROVING RESOLUTION NO. 20-036 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 4 FOR CALENDAR YEAR 2020 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-036 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council-Executive Committee of San Carlos City, Pangasinan prepared the Supplemental Annual Investment Program (AIP) No. 4 for CY 2020 in response to COVID-19 crisis. This was endorsed by the Council, through CDC Resolution No. 04-20 (Series of 2020) dated July 6, 2020, to the Sangguniang Panlungsod for approval;

WHEREAS, the Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 20-036 dated July 13, 2020;

WHEREAS, the Supplemental AIP No. 4, CY 2020, which has a total investment requirement of P26,843,400.00 is intended to augment programs/projects/activities which, accordingly, are urgent/priority needs of the LGU to address the COVID-19 emergency/pandemic;




