**APPROVING RESOLUTION NO. 187, S-2021 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 FOR CY 2021 AND REVISION OF ANNUAL INVESTMENT PROGRAM (AIP) CY 2021 OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its SB Resolution No. 187, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. No. 7160;

**WHEREAS**, the Local Development Council of Binmaley, Pangasinan endorsed to the Sangguniang Bayan for approval the Supplemental Investment Program No. 3 for CY 2021 and the Revised Annual Investment Program CY 2021 on August 12, 2021 through MDC Resolution No. 3, S-2021;

**WHEREAS**, the Supplemental Investment Program No. 3, CY 2021 covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of development projects and disaster risk reduction and management activities;

**WHEREAS**, funding for the implementation of said Supplemental Investment Program in the amount of P7,985,315.00 is embodied in the Supplemental Budget No. 3 (P5,730,315.00), which was approved and enacted by the Sangguniang Bayan on October 4, 2021 through Appropriation Ordinance No. 3, Series of 2021 and realigned Local Disaster Risk Reduction Management Fund 2021 (P 2,255,000.00);

**WHEREAS**, the Revised Annual Investment Program CY 2021, on the other hand, covers the inclusion of disaster risk reduction and management programs/projects in the previously approved AIP CY 2021 of the Municipality of Binmaley proposed to be funded from the municipality's unexpended balances of their LDRRMF CYs 2019 and 2020 (Trust Fund) in the amount of P3,483,206.46.

**WHEREAS**, these disaster risk reduction programs/projects were identified and included in the Municipal Disaster Risk Reduction and Management Fund Investment Plan Supplemental of Trust Fund, prepared and endorsed by the LDRRM Council through MDRRMC Resolution No. 02, Series of 2021;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Binmaley, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Municipal Resolution No. 187, S-2021 of the Sangguniang Bayan of Binmaley, Pangasinan, entitled “Approving the Supplemental Investment Program No. 3 for CY 2021 and revision of Annual Investment Program (AIP) CY 2021 of the Municipal Government of Binmaley, Pangasinan”;
