APPROVING RESOLUTION NO. 199, S-2020 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 6 WITH THE CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 5 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 199, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Asingan, Pangasinan has adopted and endorsed the municipality's Supplemental Annual Investment Program No. 5 thru MDC Resolution No. 6, S-2020 dated September 1, 2020 to the Sangguniang Bayan for approval. On September 7, 2020, the Sangguniang Bayan thru Resolution No. 199, S-2020 approved the Supplemental Annual Investment Program No. 5 of the municipality;

WHEREAS, the Supplemental Annual Investment Program No. 5 of the municipality with an investment requirement amounting to P2,700,000.00 covers the implementation of development projects and fund augmentation for programs/projects already included in the AIP;

WHEREAS, to support the implementation of the programs/projects embodied in the AIP of Asingan, the Sangguniang Bayan enacted Supplemental Budget No. 5 through Appropriation Ordinance No. 6, S-2020 dated September 7, 2020;
