PROVINCIAL ORDINANCE NO. 95-2001

AN ORDINANCE CREATING THE STANDING COMMITTEES OF THE 4th SANGGUNIANG PANLALAWIGAN OF PANGASINAN FOR JULY 2001 TO JUNE 2004

Be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

SECTION 1. Standing committees are hereby created by the Sangguniang Panlalawigan of Pangasinan for 2001-2004, composed of at least seven (7) members, including the Chairman, Vice Chairman, and the automatic members drawn from the Sanggunian membership, and assigned to address specific area(s) of legislation; provided, however, that no member shall be Chairman of more than one (1) regular committee or Vice Chairman of more than two (2) regular committees except those who are automatic members of said committees;

SECTION 2. Committees shall meet at the call of their respective Chairman or majority of their members;

SECTION 3. A majority of the members of a committee shall constitute a quorum to do business. Unexplained absences in four (4) consecutive committee meetings shall operate to relinquish membership therein;

SECTION 4. Standing Committees shall remain operative during the term of the 4th Sangguniang Panlalawigan and serve as a miniature legislative body whose membership and general jurisdiction are fixed and specified in the Internal Rules of Procedure of the Sangguniang Panlalawigan;

SECTION 5. Unless otherwise provided, the following standing committees are hereby created for the specified purposes and shall exercise and discharge such functions and powers as thereby provided in the Internal Rules of Procedure:

- 1.Committee on Rules, Ethics, Privileges and Laws
- 2.Committee on Good Government and Public Accountability
- 3.Committee on Monetary and Economic Affairs and Public Services
- 4. Committee on Education, Arts, Culture and Sports
- 5. Committee on Agriculture, Food and Agrarian Reform
- 6.Committee on Trade and Cooperatives
- 7. Committee on Public Works and Infrastructure
- 8.Committee on Barangay Affairs and Peace and Public Safety
- 9. Committee on Youth, Women and Family Affairs
- 10.Committee on Tourism
- 11. Committee on Justice and Human Rights
- 12.Committee on Labor
- 13.Committee on Health, Social Welfare and Development
- 14.Committee on Housing, Land Utilization and Energy
- 15. Committee on Environment and Natural Resources
