DECLARING ORDINANCE NO. 18, S-2020 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE HEREIN BELOW INDICATED NEW PERMANENT POSITIONS IN THE MUNICIPAL GOVERNMENT OF CALASIAO AS FOLLOWS: UNDER THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT COUNCIL (MPDC) - ADMINISTRATIVE AIDE III (UW II) - SG 3, UNDER THE MUNICIPAL TREASURY OFFICE - ADMINISTRATIVE AIDE III (UW-II) - SG 3, UNDER THE MUNICIPAL ASSESSOR OFFICE - ADMINISTRATIVE ASSISTANT I (BOOKBINDER III) - SG 7, UNDER THE MUNICIPAL HEALTH OFFICE - PHYSICAL THERAPIST I - SG11, UNDER THE MUN. AGRICULTURE OFFICE - AGRICULTURAL TECHNICIAN I - SG 6, UNDER THE MUN. ENGINEERING OFFICE (ENGINEERING AIDE) - SG 4, UNDER THE MENRO OFFICE - (HEAVY EQUIPMENT OPERATOR II - SG 6) IN THE MUNICIPALITY OF CALASIAO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Ordinance No. 18, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (viii) of RA 7160;

Agriculture Office - Agricultural Technician I - SG 6, under the Mun. Engineering Office (Engineering Aide) – SG 4, under the MENRO Office - (Heavy Equipment Operator II - SG 6) in the Municipality of Calasiao, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
