RESOLUTION NO. 95-2022

DECLARING THE SUPPLEMENTAL BUDGET NO. 5 FOR CALENDAR YEAR 2021 OF AGUILAR, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P3,783,364.40, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Supplemental Budget No. 5 for Calendar Year 2021 involving total appropriations of P3,783,364.40, which was enacted on December 21, 2021 through Appropriation Ordinance No. 05, Series of 2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its RR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That the upgrading of Nurse II position from SG-15 to SGH-16 shall be in accordance with Budget Circular No. 2021-2 of the Department of Budget and Management dated August 25, 2021;

3. That the appropriation for Collective Negotiation Agreement (CNA) Incentive to all municipal officials and employees of the municipality shall be subject to the provisions of DBM Budget Circular No. 2021-3 dated November 17, 2021; and
4. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2021 and its IRR, and the DBM-NDRRMC-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction Management Fund (LDRRMF).

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 5 for Calendar Year 2021 of Aguilar, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Aguilar, Pangasinan, for its information and guidance.
