## **RESOLUTION NO. 952-2021**

APPROVING RESOLUTION NO. 104, S-2021 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) OF THE MUNICIPALITY OF CALASIAO FOR THE YEAR 2021"

**WHEREAS**, the Sangguniang Bayan of Calasiao, Pangasinan submitted its SB Resolution No. 104, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council Executive Committee of Calasiao, Pangasinan prepared the municipality's Supplemental Annual Investment Program for CY 2021. This was endorsed by the Council, through MDC Resolution No. 3, Series of 2021 dated September 8, 2021, to the Sangguniang Bayan for approval;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment requirement of P 15,445,981.67, covers augmentation fund for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of the different departments of the Municipal Government, implementation of local DRRM projects, GAD-related PPAs, COVID-19 related PPAs and other development projects of the LGU;

WHEREAS, funding for the support for the Supplemental AIP will be sourced from the actual collection in excess of the estimated income, savings and reversion of funds. This is embodied in the LGU's Supplemental Budget No. 02 FY 2021, and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 05, S-2021 dated September 20, 2021. The COVID-19 related PPA's to be funded by the Development Fund. Amounting P4,000,000.00, conforms with DILG and DBM Joint Circular No. 01 dated March 27, 2020 (Additional Guidelines on the Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects in view of the Coronavirus Disease Situation);

**WHEREAS**, the Supplemental AIP also include infrastructure project which will be funded from the Local Government Support Fund-Assistance to Municipalities (LGSF-AM) of the National Government in the amount of P10,0000,000.00;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Municipal Resolution No. 104, S-2021 of the Sangguniang Bayan of Calasiao, Pangasinan, entitled "Approving the Supplemental Annual Investment Program (SAIP) of the Municipality of Calasiao for the year 2021";
