#### APPROVING RESOLUTION NO. 21-044 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 5 FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF LAOAC, PANGASINAN AMOUNTING TO TWO MILLION SEVENTY THOUSAND NINE HUNDRED PESOS ONLY (P2,070,900.00)"

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its SB Resolution No. 21-044 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. No. 7160;

**WHEREAS,** the Local Development Council of Laoac, Pangasinan has formulated and endorsed the Municipality's Supplemental Investment Program No. 5 through MDC Resolution No.2021-05 dated August 2, 2021 to the Sangguniang Bayan for approval;

**WHEREAS**, the Supplemental Investment Program No. 5 with an investment requirement amounting to Php2,070,900.00 covers purchase of one (1) unit ambulance;

WHEREAS, Appropriation Ordinance No. 21-003 enacting Supplemental Budget No. 2 for CY 2021 of the Municipality was passed by the Sangguniang Bayan to support the implementation of the Supplemental Investment Program No. 5;
