**APPROVING RESOLUTION NO. 51, S-2018 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “APPROVING THE AMENDED LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) FOR CY 2016-2019 OF THE MUNICIPALITY OF BUGALLON, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 51, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bugallon, Pangasinan had amended its Local Development Investment Program CYs 2016-2019. This was endorsed to the Sangguniang Bayan for approval on October 4, 2018 thru MDC Resolution No. 03, S-2018 and was favorably acted upon by the Sangguniang Bayan on October 9, 2018 thru SB Resolution No. 51, S-2018;

**WHEREAS**, the Local Development Investment Program of the municipality was amended to cover the project of the municipality entitled “Rehabilitation of Local Access Road @ Barangay Poblacion going to Cabayaoasan Earth Dike”, proposed to be funded from the Local Government Support Fund – Assistance to Municipalities (LGSF-AM) of the Department of the Interior and Local Government (DILG) for implementation in CY 2019;


