**PROVINCIAL RESOLUTION NO. 963-2021**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT ILOCOS FOR THE TRANSFER OF FUNDS IN THE TOTAL AMOUNT OF P66,721,199.99 TO COVER THE COST OF THE GRANT OF COVID-19 SPECIAL RISK ALLOWANCE IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, Proclamation No. 922, Series of 2020 declared a State of Public Health Emergency in recognition of the COVID-19 public health event as a threat to national security, and prompted a whole-of-government approach in addressing the COVID-19 outbreak in the country;

**WHEREAS**, RA No. 11494, otherwise known as the "Bayanihan to Recover as One", affirmed the existence of a continuing national emergency in view of the unabated spread of COVID-19 and the economic disruption ensuing from it;

**WHEREAS**, Administrative Order No. 36 issued by the Office of the President authorized the grant of Special Risk Allowance (SRA) to private and public health workers directly catering to or in contact with COVID-19 patients during the state of national emergency;

**WHEREAS**, Administrative Order No. 42 of the Office of the President authorized the extension until the end of June this year the grant of Special Risk Allowance (SRA) to frontline private and public health workers;

**WHEREAS**, for the effective implementation of Administrative Order No. 42, under Section 6.1.2 of DOH-DBM Joint Circular No. 2, S-2020, a Memorandum of Agreement shall be entered into and signed between the Department of Health and the Local Government Units and other health facilities for the transfer of funds for the COVID-19 Special Risk Allowance;

**WHEREAS**, the Province of Pangasinan is qualified to receive Special Risk Allowance for the eligible employees of the fourteen (14) public hospitals and isolation facilities operated by the Province and municipal/city health workers from the 47 component municipalities and cities;

**WHEREAS**, the Department of Health – Center for Health Development Ilocos I (DOH-CHD I) shall transfer funds in the total amount of P66,721,199.99 to cover the cost of the grant of Covid-19 Special Risk Allowance;

**WHEREAS**, the proposed agreement between the Province of Pangasinan and DOH-CHD I is executed to set forth the roles and responsibilities of the parties with respect to the implementation of the grant of the Special Risk Allowance;


**WHEREAS**, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino, III, and the DOH-CHD I, represented by Dr. Valeriano Jesus V. Lopez;

**NOW, THEREFORE**, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Amado I. Espino III, to enter into and sign a Memorandum of Agreement with the Department of Health – Center for Health Development Ilocos for the transfer of funds in the total amount of P66,721,199.99 to cover the cost of the grant of COVID-19 Special Risk Allowance;
