PROVINCIAL RESOLUTION NO. 972-2021

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH IN CONNECTION WITH THE DONATION OF A PATIENT TRANSPORT VEHICLE FOR THE PANGASINAN PROVINCIAL HOSPITAL

WHEREAS, the Department of Health (DOH), as the principal agency of the government which consistently contributes to the upgrading of medical and health care facilities, has manifested its desire to further augment its support to the Provincial Government of Pangasinan's health care program through the Health System Enhancement to Address and Limit (HEAL) COVID-19 Project;

WHEREAS, the Heal COVID-19 Project serves as the national government's vehicle by which the Province of Pangasinan shall receive assistance in the form of a donation of a vehicle;

WHEREAS, the Province of Pangasinan, through the Pangasinan Provincial Hospital, will be the recipient of a Patient Transport Vehicle amounting to P1,777,000.00 from the Department of Health;

WHEREAS, the vehicle can be used primarily and effectively to assist the Province in the disease surveillance and diagnostic capacity of COVID-19 cases;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to enter into and sign a Memorandum of Agreement with the Department of Health to further augment the need for the implementation of health programs and services to the people of Pangasinan;


NOW, THEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –
