RESOLUTION NO. 974-2020

DECLARING MUNICIPAL ORDINANCE NO. 05, S-2020 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "AN ORDINANCE IMPOSING PRICE CAP OR PRICE FREEZE ON FUNERAL SERVICES IN THE MUNICIPALITY OF BANI, PANGASINAN DURING THE DURATION OF ENHANCED COMMUNITY QUARANTINE AND STATE OF CALAMITY IN THE COUNTRY AMID COVID-19 PANDEMIC" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Municipal Ordinance No. 05, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii) and (iv) of RA 7160; DILG Memorandum Circular No. 2020-063 (Interim Guidelines on the Management of Human Remains for Patient Under Investigation (PUI) and Confirmed Corona Virus Disease 2019 (COVID-19) Cases;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jerome Vic O. Espino., duly seconded, it was –




