APPROVING SB RESOLUTION NO. 40A, S-2021 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 02 FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF BANI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 40A, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on July 5, 2021 by the MDC through Resolution No. 2021-05;

WHEREAS, the Supplemental Investment Program No. 2 for CY 2021 of the municipality covers fund augmentation for the Personal Services (implementation of second tranche of modified salary schedule of all municipal officials and employees) and Maintenance and Other Operating Expenses of some municipal offices, and the implementation of development projects and COVID-19 response-related activities;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P15,471,128.92. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 02 for Calendar Year 2021, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03, S-2021 on August 03, 2021 and approved by the Municipal Mayor on August 19, 2021;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;
