DECLARING MUNICIPAL ORDINANCE NO. 10, S-2020 OF THE SANGGUNIANG **BAYAN** OF BAUTISTA. PANGASINAN. ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY WEARING OF FACE MASKS BY ALL PERSONS IN PUBLIC PLACES AND THE WEARING OF FACE SHIELDS IN GOVERNMENT OFFICES/BUILDINGS, AT WORKPLACES, IN PUBLIC TRANSPORTATION, BUSINESS ESTABLISHMENTS AND WHILE IN PUBLIC WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN DURING THE PERIOD OF QUARANTINE AND FOR ANY EXTENSION THEREOF OR WHILE THERE IS CONTINUING LOCAL OR COMMUNITY TRANSMISSION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO **ENACT**

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Municipal Ordinance No. 10, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks or Other Protective Equipment in Public Places);

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jerome Vic O. Espino, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 10, S-2020 of the Sangguniang Bayan of **Bautista**, Pangasinan, entitled "An Ordinance requiring the mandatory wearing of face masks by all persons in public places and the wearing of face shields in government offices/buildings, at workplaces, in public transportation, business establishments and while in public within the territorial jurisdiction of the Municipality of Bautista, Province of Pangasinan during the period of quarantine and for any extension thereof or while there is continuing local or community transmission" as within the conferred powers of the Sangguniang Bayan to enact;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bautista, Pangasinan, for its information and guidance.
