RESOLUTION NO. 980-2020

DECLARING MUNICIPAL ORDINANCE NO. 10, S-2020 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY WEARING OF FACE MASKS BY ALL PERSONS IN PUBLIC PLACES AND THE WEARING OF FACE SHIELDS IN GOVERNMENT OFFICES/BUILDINGS, AT WORKPLACES, IN PUBLIC TRANSPORTATION, BUSINESS ESTABLISHMENTS AND WHILE IN PUBLIC WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN DURING THE PERIOD OF QUARANTINE AND FOR ANY EXTENSION THEREOF OR WHILE THERE IS CONTINUING LOCAL OR COMMUNITY TRANSMISSION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Municipal Ordinance No. 10, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks or Other Protective Equipment in Public Places);

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer stated in her opinion dated October 12, 2020;




RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 10, S-2020 of the Sangguniang Bayan of **Bautista**, Pangasinan, entitled “An Ordinance requiring the mandatory wearing of face masks by all persons in public places and the wearing of face shields in government offices/buildings, at workplaces, in public transportation, business establishments and while in public within the territorial jurisdiction of the Municipality of Bautista, Province of Pangasinan during the period of quarantine and for any extension thereof or while there is continuing local or community transmission” as within the conferred powers of the Sangguniang Bayan to enact;
