APPROVING RESOLUTION NO. 189, S-2021 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 FOR CY 2021 OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its SB Resolution No. 189, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Local Development Council of Binmaley, Pangasinan had identified items in their Supplemental Investment Program No. 4 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on September 30, 2021 by the Municipal Development Council through MDC Resolution No. 4, Series 2021;

WHEREAS, the Supplemental Investment Program No. 4 for CY 2021 of the municipality with a total investment requirement of P6,079,564.59, covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, and implementation of COVID-19 Control and Management programs/projects and other development projects of the municipality;
