DECLARING ORDINANCE NO. 2020-20 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING FOR STRATEGIC HUMAN RESOURCES ACTIONS UNDER THE LEGISLATIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN, TO WIT:

- 1) DOWNGRADING TWO (2) POSITIONS UNDER THE CITY VICE MAYOR’S OFFICE: FROM EXECUTIVE ASSISTANT IV TO EXECUTIVE ASSISTANT II AND FROM PRIVATE SECRETARY II TO PRIVATE SECRETARY I;**
- 2) ABOLISHING THREE (3) POSITIONS:**
 - A) UNDER THE SP SECRETARIAT:**
 - 1) ADMINISTRATIVE AIDE III (DRIVER I),**
 - 2) CONSTRUCTION AND MAINTENANCE MAN;**
 - B) UNDER THE CITY LIBRARY:**
 - 1) ADMINISTRATIVE AIDE IV (CLERK II);**
- 3) CHANGING THE POSITION TITLE OF STENOGRAPHER III TO ADMINISTRATIVE ASSISTANT III (COMPUTER OPERATOR II) UNDER THE SP SECRETARIAT; AND**
- 4) CREATING THE FOLLOWING POSITIONS: CITY VICE MAYOR’S OFFICE, 1) ADMINISTRATIVE AIDE IV (DRIVER II); SP SECRETARIAT-RECORDS AND AUDIO-VISUAL SECTION, 1) BOOKBINDER III, AND 2) AUDIO-VISUAL EQUIPMENT OPERATOR II; AND CITY LIBRARY, 1) PHOTOGRAPHER I”**

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2020-20 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 76 and Section 458 (a) (1) (viii) of RA 7160;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject ordinance in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jerome Vic O. Espino, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2020-20 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled “An Ordinance providing for strategic human resources actions under the Legislative Department of the Local Government Unit of the City of Alaminos, Pangasinan, to wit:

- 1) Downgrading Two (2) Positions under the City Vice Mayor’s Office: from Executive Assistant IV to Executive Assistant II and from Private Secretary II to Private Secretary I;
- 2) Abolishing Three (3) Positions:
 - A) Under the SP Secretariat:
 - 1) Administrative Aide III (Driver I),
 - 2) Construction and Maintenance Man;
 - B) Under the City Library:
 - 1) Administrative Aide IV (Clerk II);
- 3) Changing the position title of Stenographer III to Administrative Assistant III (Computer Operator II) under the SP Secretariat; and
- 4) Creating the following positions: City Vice Mayor’s Office, 1) Administrative Aide IV (Driver II); SP Secretariat-Records and Audio-Visual Section, 1) Bookbinder III, and 2) Audio-Visual Equipment Operator II; and City Library, 1) Photographer I”

as within the conferred powers of the Sangguniang Panlungsod to enact;






