PROVINCIAL RESOLUTION NO. 992-2021

ENDORING TO THE DEPARTMENT OF HEALTH THE APPLICATION FOR A PERMIT TO CONSTRUCT TWO (2) INFRASTRUCTURE PROJECTS AT THE LINGAYEN DISTRICT HOSPITAL, PROVINCE OF PANGASINAN

WHEREAS, the Lingayen District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 2nd District of Pangasinan;

WHEREAS, due to the pandemic, the hospital's statistics would show that between the actual implementing beds and authorized bed capacity, there is a significant increase in the number of patients being serviced by the hospital;

WHEREAS, the Provincial Government of Pangasinan through the Lingayen District Hospital intends to rehabilitate/improve the medical ward building, and construct the 2nd floor of the pediatric ward of the said hospital;

WHEREAS, in line with the main thrusts of the present administration to have a mass-based health care program to accommodate all people especially the less fortunate sector of society, there is a need to support the plan of the Lingayen District Hospital to provide a more sufficient and higher level of medical and health services to its patients through the implementation of the two (2) infrastructure projects;

WHEREAS, prior to the issuance of a license to construct, a Provincial Board Resolution is required by the Department of Health to facilitate the issuance of the permit to construct a health facility;

WHEREFORE, on motion of SP Members Jeremy Agerico B. Rosario, Nestor D. Reyes and Von Mark R. Mendoza, duly seconded, it was –




