PROVINCIAL RESOLUTION NO. 993-2021

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES FOR THE AVAILMENT OF THE POINT OF SALE (POS) DEBIT AND CREDIT FACILITY BY THE PROVINCIAL GOVERNMENT FOR CAPITOL RESORT HOTEL

WHEREAS, the Provincial Government of Pangasinan has been offered by the Land Bank of the Philippines for the availment of the Point of Sale (POS) Debit and Credit Facility in line with its thrust to provide value added collection and payment facilities to its clients;

WHEREAS, the Point of Sale (POS) Debit and Credit Facility processes bills payment transactions using an ATM/Debit/Credit Card or Prepaid Cash Card which carry the following brands: Visa, Master Card and other brands as may be identified by the Land Bank of the Philippines;

WHEREAS, the Point of Sale (POS) Debit and Credit Facility would be very advantageous to the Capitol Resort Hotel as it would provide a faster way of collection of payments and a safer and more convenient payment of bills for customers;

WHEREAS, the Sangguniang Panlalawigan finds the said system to be beneficial to the Provincial Government of Pangasinan;

WHEREAS, for the above purpose, the Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino, III, and Land Bank of the Philippines, represented by its Assistant Vice President/Head, Ms. Kathleen D. Fernandez;




