**DECLARING ORDINANCE NO. 072-2021 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE OFFICE OF THE HUMAN RESOURCE MANAGEMENT (HRMO) AND OFFICE OF THE MUNICIPAL MANPOWER DEVELOPMENT AND VARIOUS PLANTILLA POSITIONS IN EXECUTIVE AND LEGISLATIVE DEPARTMENTS OF THE MUNICIPAL GOVERNMENT AND ABOLISHING THE PLANTILLA POSITIONS OF SUPERVISING ADMINISTRATIVE OFFICER (HRMO IV) IN THE OFFICE OF THE MUNICIPAL MAYOR AND AGRICULTURAL TECHNOLOGIST IN THE OFFICE OF THE MUNICIPAL AGRICULTURIST" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its Ordinance No. 072-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 76 and Section 447 (a) (1) (viii) of R.A. No. 7160;

**WHEREAS**, however, the grade allocation of Registration Officer II should be adjusted from SG-8 to SG-10;


